<b>ROUTINE USES:</b> Disclosure of records are generally permitted under 5 U.S.C. 522a(b) of the Privacy Act of 1974, as amended. To the Department of Justice in instances where the prisoner is incarcerated in a Federal Bureau of Prisons facility and to inform U.S. Probation Officers and the Administrative Office of the U.S. Courts of the conditions of supervised release.
